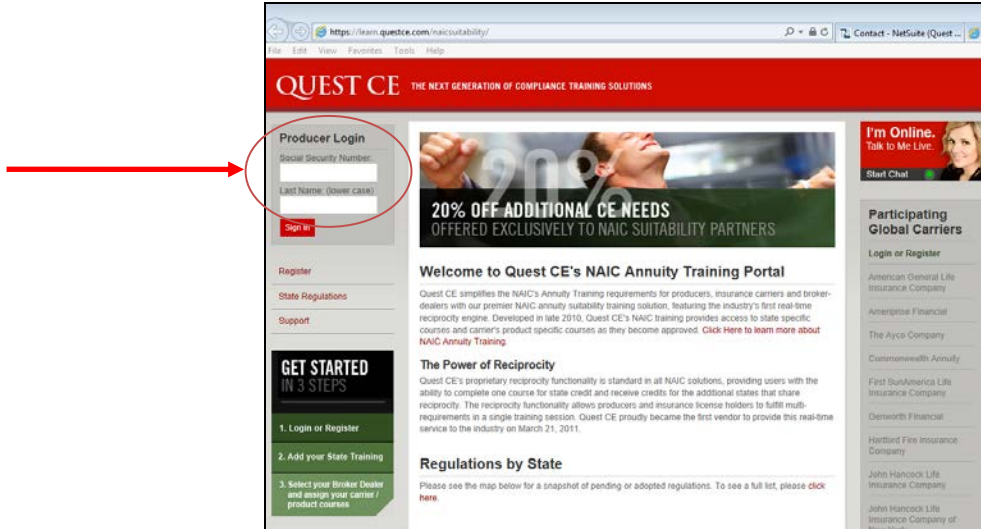




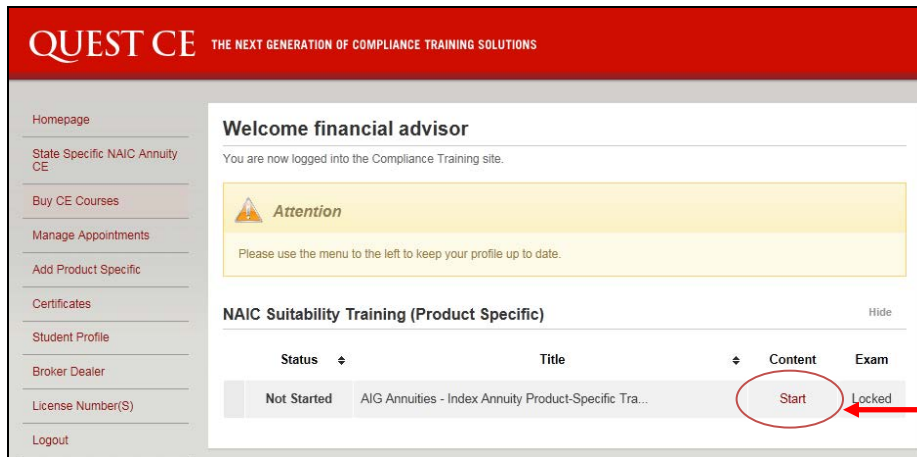

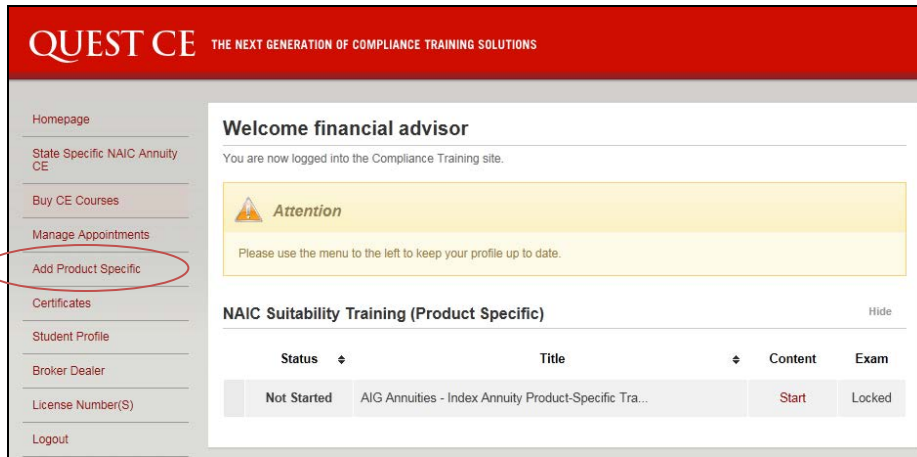
1. Go to <https://learn.questce.com/naicsuitability/>
2. Log-in to your existing account with your SSN and last name (lowercase).



3. Once logged-in, any previously selected course(s) will be displayed on the Dashboard. Click **Start** to access the AIG Annuities product-specific training for the Power Select Index Annuity products and complete the course.



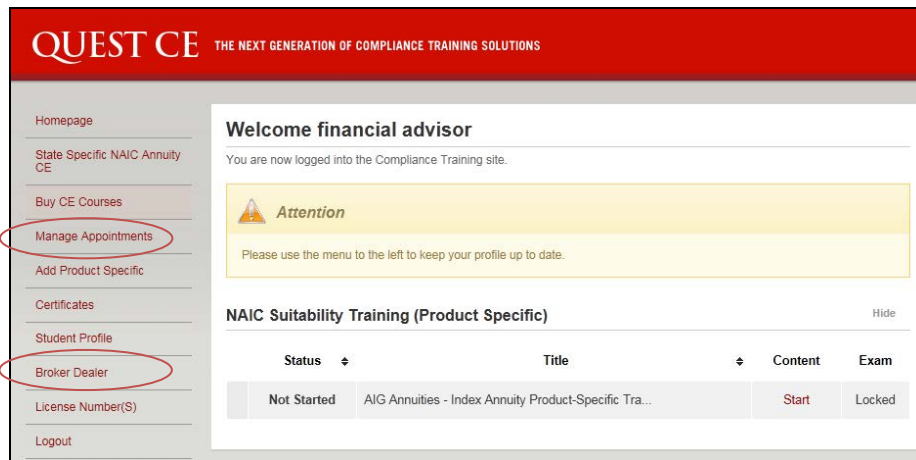
4. If the Power Select Index Annuity Training course is not listed on the Dashboard, click **Add Product Specific** from the menu options on the left.
